# Adele Roddy as Dorothy Millette: A Motion Picture Case Study

On 5 September 1932, after less than two months of marriage, Paul Bern, Hollywood writer, MGM director and husband of Jean Harlow, the "blonde bombshell" movie star, was found dead, an apparent suicide, at their Beverly Hills home. Since Bern was nearly twice Jean's age, their marriage was already under scrutiny. When news broke that a mysterious visitor that night had been his "wife" and not Jean, headlines across America focused on the mystery woman. Her name was Dorothy Millette and she had been married to Bern for nearly ten years, residing in New York City for most of that time. Days after Bern's death, following an exhaustive search of the Sacramento River, Dorothy Millette's body was found; she had apparently committed suicide two days after Paul by jumping from the steamer Delta King. Biographers for Jean Harlow and Paul Bern have called Dorothy enig-

matic, for they were not able to discover who she was. But through closer examination of her early life and associates, we can learn a great deal about her, enough to see that the part of Dorothy Millette was actually being played by Adele Roddy.

### Childhood in Indiana

Adele "Della" Roddy was the daughter of William H. Roddy and Lillie N. Johnson, born 15 March 1882 in Indianapolis, Indiana.<sup>1</sup> William H. Roddy, born about 1851, and Lillie Johnson, born about 1862, married in Independence County, Arkansas 22 June 1879.<sup>2</sup> William H. Roddy and wife Lillie N., resided in Indianapolis for the births of two more children after Adele: Viona "Ona" F. Roddy, born 21 October 1884/5, and Mary Roddy, born 1 May 1887/8.3 In 1889, William was identified as a laborer in the city directory but by 10 April 1889, Lillie had filed for divorce on complaint of "drunkenness, failure to provide and unfaithfulness."4 Lillie claimed that in August of 1888

the couple had agreed to separate, "because prior to that time Roddy was habitually drunk and unfaithful, refusing to make any provision for the custody of her three daughters, Della, seven years of age; Oma,

four and Mary, one year."5 Divorce was granted to Lilly on 21 June 1889 in Marion County, Indiana Superior Court.6

Lillie Roddy, also known as Leillas, or Lilly Johnson, found it hard to support three girls

as a divorced seamstress and became involved with a married man, who

promised to divorce his wife, although that did not happen. By February 1894, Lillie had put the girls in the temporary care of the Board of Children's Guardians, and permanent custody was granted to them in 1895.7 The Board of Children's Guardians was to "have supervision over neglected and dependent children under fifteen years of age." All three, Adele, Oma, and Mary Roddy, were under the organization's care in 1895 and in their records until 1905.8

The girls' progress and indenture history was recorded: Oma was still communicating with her mother in July 1896 and was quickly placed elsewhere out of concerns that her mother would come for her; Della was in as many as five different placements and in November 1896 she was reported as not attending school, claiming to be sixteen years old, (when she was thirteen), and lying, but she eventually regained the Guardians' good faith as they felt she was smart and so was sent to stenographer school; Mary was fortunate to be in the same household her entire time with the Board and

became a proficient violinist.9 All the while the Roddy girls kept in contact with each other.

By 1900 the girls were living in different households: Adele, as "Addy" Roddy, was a boarder in the Henry J.

and Mary E. Whitmer household in Green Township, St. Joseph County, Indiana;<sup>10</sup> Oma, as "Viona" Roddy, was a servant in the Charles Sample household in Warren Township,

Marion County, Indiana; and Mary Roddy was a boarder in the household of Oliver and Emily Staats in Helt Township, Vermillion County, Indiana.<sup>11,12</sup> There is no evidence that the girls were ever returned to the care of their mother, but there was a notation in their file: "Lillas Roddy was divorced from her husband W. H. Roddy & afterward married a Swede [and was] renamed Lilly Hade...[she died and] was a morphine fiend as was also W. H. Roddy. Mr. Barrett her attorney says she became demented. He is looking up an estate on the Pacific Coast in which it is said the Roddy girls have a share."<sup>13</sup>

### **Dorothy Roddy and Her Sisters**

Within a few years the Roddy girls had become stenographers, residing in Indianapolis. Viona married John H. Henselman on 22 July 1904;<sup>14</sup> Mary married Charles C. Vinier on 18 October 1905;<sup>15</sup> Adele, known as Dorothy Roddy, married Lowell Mellett on 22 June 1907.<sup>16</sup> Once the Roddy girls married, they moved with their husbands. Viona Henselman moved to Portland, Oregon and appeared there in the 1910 census while Dorothy moved

to Tacoma, Washington, where her husband Lowell was a local newspaper reporter.<sup>17</sup> Lowell and Dorothy Mellett were in Tacoma from 1910 to 1912, according to the city directories. Although

her married name was Mellett, Dorothy used "Millette" consistently and that spelling appears in the records most often. In 1912, Viona's husband John Henselman passed away and, soon after, Viona moved to California.<sup>18</sup>

### Dorothy Millette and Paul Bern

Most accounts state that Paul Bern met Dorothy Roddy Millette in 1911 and that they lived as man and wife from that point forward, in spite of the fact that there are several documents which don't match these accounts, such as the fact that Dorothy's divorce from Lowell Mellett was not finalized until 1913 and that Paul listed himself as single on and off for years during their "marriage."<sup>19</sup>

Paul Bern, also known as Paul Levy, was born 3 December 1889 in Wandsbeck, Prussia and had migrated with his parents, Julius and Henrietta (Hirsch) Levy to the US on the Pennsylvania.<sup>20</sup> Paul lived in New York City where he appeared in the New York 1900, 1905, and 1910 censuses.<sup>21</sup> When he first applied for naturalization in 1910, he listed his occupation as author.<sup>22</sup> In 1911, Paul graduated from the American Academy of Dramatic Arts (AADA), adopted the surname Bern, and began traveling with acting troupes that toured the country. Many accounts state that Paul first met Dorothy in 1911 in Toronto, but they actually met when "Mrs. L. Mellette" enrolled in May 1912 in the AADA.23


Lowell Mellett filed for divorce from Dorothy in August of 1913 because "without just cause, defendant has continuously abandoned plaintiff for more than one year last past."<sup>24</sup> Dorothy's Seattle lawyer responded to the claims Lowell put forth in court and the divorce was granted 18 August 1913,

Paul took out several life insurance policies at this time ... with the stipulation that both parties could not marry until six months after that date.<sup>25</sup> Some sources state that Paul and Dorothy married in 1914 while later court cases state that they lived as man and wife

from 1911 forward—but these dates conflict with the divorce date for Dorothy.<sup>26</sup> Paul took out several life insurance policies at this time, some of which may have been purchased while he was living in Glens Falls, New York; Woonsocket, Rhode Island; and Wilmington, Delaware, all places the troupe toured.<sup>27</sup> Years later it was inferred that Dorothy was identified as his wife and heir in these life insurance policies.<sup>28</sup>

Although no actual marriage record has been located in any earlier residences for the couple, by February, 1917 Paul stated on his

naturalization application that he was married to Dorothy and that she had been born 16 March 1889 in France, a birthplace fiction that all of the Roddy girls would ultimately adopt.<sup>29</sup> Known as Paul and Dorothy Bern, the couple resided in Manhattan for the 1920 census and identified themselves as married, a director and actress.<sup>30</sup> It was suggested that Paul's mother, upset about Paul living with a woman outside his faith, committed suicide 15 September 1920, but the death was officially ruled an accident.<sup>31</sup> Soon after, according to several researchers, Dorothy had a mental breakdown and was committed to Blythewood Sanitarium for about eight months, and then lived for years, until May 1932, at the Algonquin

Hotel in New York City.<sup>32</sup> Meanwhile, Dorothy's sister Viona married in King County, Washington, to Herbert E. Hessler on 8 April 1932 but returned to her California residence afterward.<sup>33</sup>

The year that Paul and Dorothy supposedly met and began living together, 1911, was the same year

that Harlean Harlow Carpenter, also known as Jean Harlow, was born, on 3 March, in Kansas City, Missouri.<sup>34</sup> Harlean took on her mother's maiden name when she began her movie career and by the time she married Bern in 1932 had starred in twenty-nine films, including Hell's Angels, Public Enemy with James Cagney, Platinum Blonde, and Red-Headed Woman.<sup>35</sup> Jean Harlow and Paul were acquainted as early as 1930 when he escorted her to the opening of Hell's Angels, and the two often worked together. Paul's M.G.M. connections probably got her better parts in movies.<sup>36</sup>

#### **Tangled Relationships**

Paul moved to California from New York City around 1925. In 1926, he took a trip to Hawaii where he identified himself on the manifest as single as he also did in 1930.<sup>37</sup> In 1932, he produced *Grand Hotel* and Dorothy apparently moved to Sacramento where she resided in a hotel from May 1932 until her death.<sup>38</sup> On 2 July 1932, Paul Bern—claiming to be single and registering his first marriage—married Harlean Carpenter McGrew in Los Angeles, with Irving Thalberg and Irene (Mayer) Selnick as witnesses.<sup>39</sup> Interestingly, Paul wrote a revised version of his will that same month.<sup>40</sup>

The events on the evening of 5 September 1932 have been discussed by many authors,

while reporters tried to find more information on the woman, Dorothy Millette.<sup>42</sup> Some accounts said that Dorothy had moved from New York to Sacramento. Two days later, Dorothy Millette jumped to her death from the *Delta King.*<sup>43</sup> She was not found for several days. At this time Dorothy's sister Viona lived in Alam-

eda County, California while her other sister Mary was in Hancock County, Ohio.<sup>44</sup>

The public county administrator in Sacramento sought relatives of Dorothy for the few possessions that she had left on the *Delta King*, but her body remained unclaimed.<sup>45</sup> Dorothy's estate

was entered into court 27 September 1932.<sup>46</sup> On 4 February 1933, Dorothy's sister Mary, now Mary Hartrauft, passed away from breast cancer in Ohio.<sup>47, 48</sup>

It was assumed that Paul Bern had money and, that if Dorothy Millette was the rightful wife of Paul, that her heirs would receive their portion. Paul's will had been revised after his marriage to Jean and left all to her, but there was not much.<sup>49</sup> In 1934, when Jean was dubbed one of the highest paid stars in Hollywood by Motion Picture Herald, Herman Koch, the public county administrator of Sacramento, sued Jean on behalf of Dorothy's sister Viona and the estate of deceased sister Mary Hartrauft, for half of the life insurance policies that Paul had taken out in the 1910s.<sup>50</sup> Half was estimated to be \$24,000 and Koch claimed that since Dorothy and Paul were never divorced, the money should be awarded to Dorothy's heirs.<sup>51</sup> Jean had an excellent lawyer and nearly every claim was stricken until the case was dropped completely.

Jean went on to make many more movies, but on 7 June 1937 at the age of twenty-six, she died of acute nephritis from kidney failure.<sup>52</sup> The funeral is said to have been one of Hollywood's most extravagant. Seventeen days later, Dorothy's remaining sister Viona Hessler died in Oakland, California.<sup>53</sup>

#### Setting the Record Straight

Known for her death and her connection to a Hollywood conspiracy, much of the life and parentage of Dorothy Millette has been unknown and treated as a mystery for years. By

to Bird and he says: 'This is not the kind of a thing I want... I want my books kept so that no expert can come into my office and trace up a dollar of the money that has gone through this office unless I want it so traced up.' He said to Bird then and there, 'You need not keep any more books.' From that time down to the time Bird quit that office, on the 19th of August 1897, no books were kept.

"When he came back to that office he found Griffith in a drunken condition... He no longer threatened; he no longer cursed and swore at him; no longer charged him with ingratitude; but he was sweet as honey and as oily as you will find him when he gets on the witness stand. He wanted to patch it all up."

As the account concludes, "The statement of Mr. Dillon was very lengthy, and only its salient features have been here presented. It created perhaps the greatest sensation of the year in the superior court."

#### **Found Guilty**

When the third trial commenced, Bird was confident of acquittal. "The defendant himself was attired yesterday in a Prince Albert coat, high collar and his usual self-complacence. That he expects an acquittal is self-evident."<sup>10</sup> In spite of the aggressive defense of Dillon, once again Bird was found guilty and this time sentenced for six years.<sup>11</sup> Dismissing his attorney, Bird appealed on his own behalf for a new trial to the Supreme Court, upon certain grounds which were found by the judge who tried the case to be well taken.<sup>12</sup> But when he applied for bail he was denied and he remained in the county jail. The Supreme Court did not act for months.

While awaiting the outcome of the appeal, Bird, despondent, attempted suicide on 10 25
