[Redacted] (7), [Redacted] (9) and child unknown (11) live with their mother LaToya Ammons at [Redacted] Gary IN Lake Co.

RS states the children were at their primary care physician's office and he sent them to the ER. RS states the mother has reported that there are demons in the home and they are attacking the children. RS states the mother reported that the children fight one another and are abusive to one another and then they pass out.

RS states [Redacted] reported that there are ghosts in the home, thousands of them and he can see them. RS states [Redacted] reported that they don't talk to him but after the mother tells [Redacted] that he can tell the medical professionals the truth he later says yes. RS states [Redacted] reported that one demon told him that he was going to hell and that he wasn't going to God.

RS states they believe that a month ago everything was relatively normal. RS states the family recently moved but they are unaware of where they moved from. RS states within the last month it started with one child acting out and fighting then it was

with all the children being very violent with each other in public but especially with the mother present.

RS states they believe the mother may have mental health concerns. RS states they believe the children are performing for the mother and that she's encouraging the behavior.

RS states the children are in the hospital at this time and haven't been in the hospital for longer than 30 minutes.

RS reports they are unaware of information regarding worker safety concerns in the home.
